- Accept adjudication applications from claimants;
- Provide advice and assistance to parties regarding the adjudication process;
- Nominate an appropriate Adjudicator to decide an adjudication matter;
- Issue Adjudication Certificates to claimants upon request;
- Where approved to do so by the Adjudication Registrar, conduct courses for Adjudicators in the prescribed adjudication qualification and upon successful completion, issue a Certificate in Adjudication to the Adjudicator.
